# TERMS & CONDITIONS

## CONFIRMATION & PAYMENT POLICIES

### Reservation Deposit

For *FITs, Groups, and Charters*, a non-refundable 20% deposit of the invoice total is required within 8 business days from the booking date. Only when this deposit is received, the booking is considered confirmed. If no deposit is received within 8 business days, the spaces on hold will be released.

### Final Payment

Final payment (balance) must be completed at least 60 days prior to the cruise departure date for *FITs* and 120 days prior to the cruise departure date for *groups and charters*. If the payment is not received by this deadline, spaces can be offered to other travelers.

## CANCELLATION POLICIES:

### *For FITs:*

Cancellations made 60 or more days prior to the cruise departure date, only the deposit will be withheld.

Cancellations made between 59 – 0 days before the cruise departure date, full payment will be withheld.

### *For Groups and Charters:*

Cancellations made 121 or more days prior to the cruise departure date, only the deposit will be withheld.

Cancellations made between 120 - 0 days before the cruise departure date, a penalty of 100% will apply.

## PRICE INCREMENT

Any increments in fuel, airport taxes, etc. above 2% from the cost of the cruise, will be covered by the passenger as a Fuel Surcharge to be announced by Via Natura.
