A) PAYMENT TERMS & CONDITIONS

PAYMENT – PREPAYMENT

- The Operator must make all payments to the hotel in the currency agreed as per signed contract.
- All payments by the Operator to Hilton shall be made without deduction or short payment for any reason whatsoever.
- All bookings must be prepaid. Advance payments to be received by the hotel and clear in the bank no later than 14 working days prior to the date of arrival of guests. This can be done either by bank transfer or credit card payment plus bank fee.
- Invoices will be deemed to have been accepted as presented unless disputed within 7 days of receipt.
- Vouchers – it is the Tour operator responsibility to ensure that the guest has the original voucher for presentation on check-in. Should the guest arrive without a voucher, the hotel reserves the right to request payment on arrival.
- In the event of any guest complaint, the Operator shall immediately refer this complaint to the Hotel. The Operator shall not make any payment, refund or concession to the Guest concerned without the prior written approval of Hilton.

PAYMENT – CREDIT FACILITIES

- The Operator must make all payments to the hotel in the currency agreed as per signed contract, unless specified otherwise in writing.
- All payments by the Operator to Hilton shall be made without deduction or set off for any reason whatsoever.
- The Operator must pay all sums owing under such credit facilities within 30 calendar days of receiving notice from Hilton that any pre-authorized credit limit has been reached and in all other cases pay all sums owing following Hilton issuing invoices within 30 days of date of the final invoice.
- If pre-authorized credit facilities have been agreed, non-payment of invoices by the relevant due date or non-payment once the pre-authorized credit limit has been reached may result in their withdrawal of the credit facilities. In addition hotel reserves the right at its discretion to levy an interest charge of 3.0% monthly on the total invoice amount.
- The maximum amount of credit allowed is as per the credit application form approval.
- Invoices will be deemed to have been accepted as presented unless disputed within 7 days of receipt.
- Vouchers – it is the Tour operator responsibility to ensure that the guest has the original voucher for presentation on check-in. Should the guest arrive without a voucher, the hotel reserves the right to request payment on arrival.
- In the event of any guest complaint, the Operator shall immediately refer this complaint to the Hotel. The Operator shall not make any payment, refund or concession to the Guest concerned without the prior written approval of Hilton.

I1) GENERAL

- This Agreement does not cover other negotiated or corporate rates.
- Net contracted rates must include a markup and/or be incorporated into a package before resale.
- The net price for package components may not be itemised to view the room rates separately at any time.
- Hilton shall not be liable to the Company or guest by reason of any failure to or delay in performing any of our obligations under this Agreement if the delay or failure was due to 'Force Majeure'.
- For the purposes of this Agreement, 'Force Majeure' shall mean any cause beyond the Hilton's or Hotel's reasonable control, including without limitation: Fire, flood, explosion, earthquake, storm or other natural disaster, civil commotion, strike, embargo any fault or delay by their sub-contractors or any industrial or civil dispute confined to part or all of their workforce, hostilities (whether war is declared or not), sabotage, terrorist attack, or the acts or decisions of any governmental, public or judicial authority (otherwise than pursuant to the act or default of the party concerned) or the imposition of any independent government sanction, or similar action made after the date of this Agreement.
- The hotel reserves the right to refuse entry to and remove any guest from the hotel if any authorised person of Hilton Worldwide considers in his/her reasonable opinion that the guest is intoxicated, inappropriately dressed, or behaving in a threatening, abusive, or otherwise unacceptable manner.
- The Company shall indemnify and hold the hotel harmless from and against all losses, claims, liability, costs, damages, fines or expenses (including all legal costs) incurred or suffered by the hotel arising out of or in connection with any errors, omissions or inaccuracies made by the Company in completing a booking.



12) PREFERRED PLACEMENT

- The Company shall promote Hilton's room inventory and products online and offline favourably.
- The Company shall guarantee that, when selling online, they will appear on the first page above the fold for the applicable destination search.
- The hotel must approve all brochures and online pages before publication.
- The hotel will not take any responsibility for any information published online or in a brochure that does not have the required approval from the hotel.
- Any and all brochure contribution invoices need to be invoiced within the contract period in order to be paid by the hotel. For invoices received after the 12-month period of this contract, the hotel reserves the right to refuse payment.

13) EXCHANGE RATE

- Should there be an important fluctuation in the conversion of the exchange rate from the currency quoted above to the Seychelles Rupee, we reserve the right to adjust the rates accordingly.

14) HOTEL CANCELLATIONS AND NO SHOW

- **APPLICABLE DURING: Full Year with the exception of EASTER, SUMMER and FESTIVE:**
 - 50% of BB room rate for the length of stay for cancellation received within 08 -14 days.
 - 100% of BB room rate for the length of stay for cancellation received less than 07 days.
- **APPLICABLE DURING: EASTER AND SUMMER: 16-Jul-24 to 24-Aug-24, 12-Apr-25 to 06-May-25 & 16-Jul-25 to 25-Aug-25:**
 - 50% of BB room rate for the length of stay for cancellation received within 22 - 30 days
 - 100% of BB room rate for the length of stay for cancellation received less than 21 days
- **APPLICABLE DURING FESTIVE SEASON: FESTIVE SEASON 24-Dec-24 to 08-Jan-25:**
 - 100% of BB room rate for the length of stay for cancellation received less than 30 days
- Guests departing before their booked checkout date will be charged for the remaining nights.
- The Hotel has the right to charge 'no-shows' /cancellation fees automatically as per the conditions above.
- Cancellation fees will be waived as long as the Company has cancelled the room(s) in writing and the hotel received confirmation from the hotel of receipt of the cancellation.

15) ACCOMMODATION

- In the unlikely event that the hotel does not, for any reason, have the number and type of rooms required by the Operator as per the booking, Mango House Seychelles, LXR Hotels & Resorts reserves the right at its discretion to relocate the guest concerned to an alternative hotel of a similar or higher standard.

16) CHECK IN & CHECK OUT POLICIES

- Check in time 14h00 / Check out time 11h00 AM.
- Early check-in before 14h00 and late check-out after 11h00 AM are based on availability, as determined on the day of arrival or departure, as the case may be, and are subject to additional charges.

- The Operator acknowledges and agrees that it will advise prospective guests as part of the terms and conditions for accommodation that:
 - Guests are subject to and accept Hilton Worldwide terms and conditions prevailing at the time of the booking and,
 - that the reserved accommodation will not be available earlier than 14h00 on the day of the guest's arrival. For guaranteed early check-in, the previous night will be charged at the full contracted rate.
- The Company acknowledges and agrees that it will advise guests that the reserved accommodation must be vacated no later than 11.00 AM on the date of the guest's departure.
- The Company shall ensure that guests are informed that failure by the guests to do so may incur a late departure charge which must be settled by the guest on their departure.
- A charge of 50% of the room rate will apply for late checkouts between the standard checkout time and 4:00 PM. Checkouts after 4:00 PM will incur a full night's charge.

17) GROUP BOOKING

- The rates listed above do not apply to group reservations. For bookings of 9 rooms or more, please call the Hotel directly for rates and availability.

18) BOOKINGS, PRODUCTION, STOPSALE, ALLOTMENT & MATERIALISATION

- Any changes to a booking within the release period will be considered as new reservations and will be subject to the hotel's availability.
- Additional business booked will be charged at the same rates, if the hotel booking situation allows it and if this is specifically reconfirmed for each particular departure by the hotel. If this is not the case, such additional business may be charged at regular group or individual rates as determined by the booking situation.
- In order to make a booking of any accommodation, the Company must send a reservation notice. Once we have received the notice, this then shall be referred to as a booking and confirmed by the hotel in writing.

- Company agrees that this Intermediary Agreement is not effective unless and until, and is conditional upon, approval of Company by Hilton Hotels Corporation ('Hilton') for such services.
