Transfers

COMO Maalifushi is located in the Thaa Atoll and is accessible by sea planes.

- The seaplane transfers are carried out by *Manta Air* and the flight duration to the resort is 60 minutes.
- COMO Maalifushi will assist in booking and coordinating the transfers from and to Male International Airport. Guests flight details must be submitted by the tour operator 7 days prior to arrival to res.maalifushi@comohotels.com
- Flight schedules are operated by Manta Air and could at times be subject to change due to operational requirements or weather conditions. It is not the responsibility of the resort if the flight operator delays or cancels flight due to one of the above reasons.
- As per flight safety and security regulations the seaplane flights are only operated in day time hours. Late evening transfers are not available and Government regulations mean that seaplanes' final take-off is at 4.30pm each day. Therefore it is necessary to advise the guests that arrivals after 3.30pm will require for overnight stay in our sister property COMO Cocoa Island (additional roundtrip speedboat charges apply) or alternatively request a domestic flight transfer if available at time of guests scheduled arrival.
- Seaplane departure time from the resort to Male International Airport will be advised one day prior to departure. Resort doesn't guarantee last minute request for arrival or departure, neither direct transfer to and out from the resort without stopover in another resorts nearby.
- In case of any international delays or "force majeure" where the seaplane cannot be connected to the island, the resort will endeavour to offer alternative transfer arrangements, for which guests cannot claim any refund
- The standard permissible weight is 30kg, which includes 25 kg of checked in luggage and 5 kg of hand luggage per person. Supplement charge apply for overweight.
- Seaplane rates are subject to change by the service provider without notice. In this circumstance COMO Maalifushi will not absorb additional rate differences prevailing to the change in seaplane rates.

- **Rates**
 - The wholesale net rate quoted are **20 per cent** discounted from published rate.
 - All of the above rates are quoted in US dollars (\$) per room per night based on the standard room occupancy on a bed and breakfast basis unless otherwise stated, and are net of commission.
 - All room categories with one bedroom are based on double occupancy, per room.
 - Discounts and mark ups are not applicable on any meal plans, transfer, other supplements or services.
 - When sold as a standalone rate i.e. not packaged with flights and other services, the tour operator agrees to mark-up contracted net rates by minimum 20 per cent. Failure to do so may result in the termination of this agreement.
 - In the event of any in-house upsell or upgrades for guests during the stay, of already confirmed reservations the Tour Operator will not be eligible for compensation.
 - All rates are inclusive of service charge and government tax as follows: 10 per cent service charge and prevailing government taxes.
 - A minimum stay of five nights is required from December 26, 2025, to January 2, 2026.
 - Rates are based on a Non-Last Room Availability (NLRA) status.
 - Government tax is subject to change by the government without notice. In this circumstance COMO Maalifushi will not absorb additional taxes.
 - Bookings for a total of 10 rooms or more shall be classified as group bookings and will be subject to group rates, terms, and conditions.
- **Green Tax**
 - The sum of US\$6 shall be collected by the Republic of Maldives as Green Tax (in addition to current taxes) from each tourist per day of stay at COMO Maalifushi. This will be invoiced at the time of booking.
 - This tax applies to all ages and is also payable on complimentary nights.
- **Contracted Offers**
 - Contracted Offers are based on two people in a one-bedroom accommodation, four people in a two-bedroom accommodation or eight people in a four-bedroom accommodation.
 - The Stay Save Discount does not apply to à la carte meals, transfers, extra person supplement or any other services.

 - Children dining off the restaurant's à la carte menus, opting for a child size portion, will be charged at 50 per cent of the published rate.
- **Butler Service**
 - Complimentary dedicated 24-hour butler service is included for all Maalifushi Beach Villa, Maalifushi Water Villa, COMO Villa and COMO Residence reservations.
 - Shared Butler Service for all rooms
- **Check in/out**
 - Check in is after 2.00pm on day of arrival and check-out is by 12.00pm noon on the day of departure
- **Guest Property**
 - The Hotel shall not be liable for any loss or damage to property owned by, or in the custody of, the Client its guests, employees, agents or others. Safe deposits boxes are available for the use.
- **Limitation of Liability**
 - Except as expressly set forth in this agreement, neither party makes any warranties, expressed or implied. Except for the indemnification obligations set forth in this agreement, neither party shall be liable for consequential or indirect loss of any kind, even if the other party has been advised of the possibility of such loss occurring.
- **Indemnification**
 - Hotel shall, at their expense and at Client's request, hold harmless, indemnify and defend Client, any Affiliate, or any of their directors, employees, or agents, against any third-party claim or action brought against any of them, arising from or relating to Hotel's accommodations or services or Hotel's breach of this Agreement.
 - Client shall, at its expense and Hotel's request, as applicable, hold harmless, indemnify and defend Hotel against any third-party claim or action brought against the Hotel, any of their affiliates, or any of their directors, employees, or agents, relating to (i) the booking of reservations through Client's Systems, or (ii) any breach of this Agreement by Client. The indemnified party is seeking indemnification ("Indemnification Claim"); the failure to give prompt notice shall not relieve the indemnifying party of its obligations except to the extent that the indemnifying party is damaged as a result. At all times, the indemnified party shall have sole control over the defence and settlement of an Indemnification Claim. Any indemnified party has the right, but not the duty, to participate in the defence and/or settlement of any Indemnification Claim with counsel of its own choosing and at its own expense, provided that the indemnified party and its counsel cooperate with and follow the direction of the indemnifying party in the defence of such Indemnification Claim.
- **Confidentially**
 - Without the express written consent of the disclosing party, no party shall disclose or allow the disclosure to any third party, or use other than as specifically permitted in this Agreement, any confidential, proprietary or trade secret information of such disclosing party. A party shall not be liable for the disclosure of any confidential, proprietary or trade secret information if such information (i) becomes publicly available without the receiving party's breach of any obligation owed to the disclosing party, (ii) became known to receiving party prior to disclosing party's disclosure of such information, (iii) became known to receiving party from a source other than disclosing party where such source did not breach an obligation of confidentiality owed to disclosing party, or (iv) is independently developed by the receiving party. If Client provides Hotel access to an extranet, Hotel shall (a) allow access to such extranet only to its employees who have a legitimate need for such access and to Authorised Third Parties for the sole purpose of fulfilling Hotel's obligations under this Agreement, (b) inform Client in writing of all employees with access to such extranet, including any changes to such employees, (c) keep confidential, and require Hotel's employees and Authorised Third Parties to keep confidential, all passwords and other security measures necessary to access such extranet, and report

any unauthorized access to such extranet, and (d) prevent the use of any automated scripts or software to repetitively query the extranet to gather information. Hotel, as applicable, is responsible for the use of the extranet by anyone using Hotel's password or other access permissions. Any direct connect functionality implemented for the Hotel(s) shall be governed by Client's then-standard direct connect terms and conditions. "Authorised Third Parties" means a third party hired by Hotel under a written contract, and approved by Client in writing, to access Client's extranet and perform online rate and room management services.

- **Force Majeure**

- A Party's failure to perform under this Agreement is excused if the failure results from an unforeseeable cause beyond that party's control, such as war, earthquake, epidemic, pandemic, accident, explosion, casualty, strike or work stoppage, lockout, civil disturbance, act of public enemy, embargo, terrorist act, fire, weather events, air carrier interruption, or act of government. A party whose performance is impaired as a result of such an unforeseeable cause shall promptly notify the other parties.

- **Termination**

- Either party may terminate this Agreement at any time upon 30 days' written notice to the other party.
- The Hotel reserves the right to cancel any booking made in breach of this Agreement.
- Upon termination of the Agreement, the Hotel and Client will continue to honour the terms of the Agreement with respect to any booking made prior to the termination date for dates following the termination date, unless termination occurred due to a monetary breach.

- **Brochure/Website**

- The Client agrees to feature the Hotel in programs and brochures as a "deluxe five star" hotel, including photographs provided by the Hotel when appropriate. Brochure copy and layout must be approved prior to printing. Hotel will not be responsible for mistakes if approval is not sought. Images can be obtained from the following link www.comohotels.com/photolibrary
- Client and its affiliates agree that they will not bid on any Hotel brand name keywords, Hotel names and/or permutations thereof. Hotel will consider that a copyright violation and reserve the right to terminate this agreement immediately, this would include any pay-per click advertising on same.
- Cyber-squatting: Client agrees not to register any domain names which might be construed by the user as belonging to or associated with Hotel or its affiliates, nor will they supply inventory through any affiliate network to any persons operating a domain or URL of same. Should Hotel determine that any non-approved URL or portal is gaining access Hotel room inventory through Client's program, Client will immediately, at Hotel's request assist Hotel in the cease and desist process.

- **Publicity**

- Neither party will release a press release that identifies the other party, via use of the company name or trademarks nor otherwise, without the prior written consent of the identified party, which approval may be granted or withheld in the identified party's sole discretion.
- The Wholesaler should not bid on or purchase internet placement rights for our brand keywords in any manner or in any of its advertising, including but not limited to Internet and web advertising, without the express written consent of the Hotel.

- **Onward Distribution**

- Under no circumstances are rates in wholesale contracts to be published on the Internet or to the public without bundling it with airline tickets, etc. as a package.

- **Predatory Advertising**

- A predatory advertising method is an advertising method that creates or overlays links or banners on web sites, spawns browser window, or utilizes any other method to generate traffic from a web site without that web site owner's knowledge, permission, and participation. Therefore, the Wholesaler should not use and discourage all web sites within their control from using, any predatory advertising methods designed to generate traffic from COMO Brand sites, or any other sites that exclusively promote or mimic COMO Hotels and Resorts brands.

- **Use of the wholesale rates**

- The wholesalers should make best efforts to ensure that all wholesale rates are packaged or bundled. In cases, where an unpackaged rate is sold, it should at least equal to the Best Available Rate of the hotel or an appropriate mark-up be applied to maintain integrity.

- **Payment Terms and Cancellations**

- Unless credit facilities have been approved, full payment must be received prior to guest arrival. For more details please refer below.
