Wild Hill at a glance

Wild Hill is an exclusive use property with five luxurious suites, each designed with the utmost attention to detail and comfort. Named simply after numerical Maasai numbers, each suite has a spacious lounge, with a coffee station, mini bar and fireplace, huge bedrooms with baths overlooking the vast plains. There are indoor and outdoor showers and verandah that stretch across the front of the suites, making the most of the views below.

The Guest Suites

Nabo [Nah - boh]:

The family suite, with two ensuite bedrooms and a shared living area set inbetween massive boulders.

Are [Ah- reh]:

Tucked down on the edge of the hill, in a colobus grove, set inbetween ancient fig trees.

Uni [Oo-ni]:

Further along the ridge, looking over the rocky outcrops that frame the wide open views.

Ungwan [Ong - won]:

Set on the edge of the ridge with grassy knowles and looking over the rocky outcrops and vast plains beyond.

Terms & Conditions 2025

① Bookings are accepted on the understanding that guests have their own comprehensive travel insurance with at least cover for Medical, Repatriation and Cancellation included. The policy number, Insurance Provider, and emergency contact information, to be provided before the commencement of the journey.

② Bookings are confirmed upon receipt of a 20% **NON-REFUNDABLE** deposit.

③ Balance payable in full 46 days prior to arrival.

④ Guests are required to complete a registration form on arrival.

⑤ Room / Tent check in is 11:00 AM on day of arrival and check out time is 10:00AM on the day of departure.

⑥ **In the event of cancellation:** Between 45-31 days 50% of the full payment will be forfeited and 50%

will be refunded. Cancellations within 30 days of arrival 100% cancellation fee.
