RATE TERMS AND CONDITIONS

- Rates are per suite per night, quoted in Malaysian Ringgit (RM), and are non-commissionable.
- Rates include breakfast and 8% Sales & Service Tax (SST). The resort reserves the right to amend taxes and fees following increases imposed by the Malaysian government, without prior notice.
- Rates are exclusive of the RM 10 Tourism Tax per suite per night and payable by the guest upon check-out. The Tourism Tax applies to all non-Malaysian nationals staying at the resort.
- Rates include one activity per person per day for 2 adults.
- Rates must be packaged with at least 2 other components i.e., ground operator and airline.
- Rates are valid for FIT (individual) bookings up to 4 rooms per booking. Rates for group, conference, incentive, or event business are available upon request.
- Rainforest Junior Suite, Ocean Junior Suite, and Ocean Front Junior Suite are on Free Sale. Free sale reservations must be reported to the reservations department within 24 hours. The remaining suite categories are On Request.
- One&Only Desaru Coast reserves the right to modify or withdraw these rates at any time during the term of the agreement upon notice to the Contracting Partner. One&Only Desaru Coast may terminate this agreement on 30 days' written notice to the Contracting Partner. This agreement shall be governed by the laws of Dubai and the applicable Federal laws of the United Arab Emirates and in the event of dispute, the courts of Malaysia shall have exclusive jurisdiction.
