1. All rates are confidential and must be packaged with complete land, tour or air arrangements at all times. The Hotel reserves the right to terminate this contract for failure to comply with this condition. The preferential rates extended are not applicable for online distribution.
2. Rates are extended on the understanding that the Hotel will be featured in promotional tour brochures as a 5-star deluxe Hotel and a copy of the program must be submitted to the Hotel, this contract will not be valid if our hotel is not featured in your program and printed color brochure with pictorial and text exposure. A copy is to be sent to the hotel immediately on publication.
3. Use of the rates is strictly for FIT Leisure packages. Rates are not applicable for Corporate Meeting, Ad hoc group, Incentive and Exhibition. Groups are defined as 10 rooms and above and group rates will apply. The Hotel reserves the right to terminate this contract for any misuse of the rates other than the purpose of Leisure packages, program or series.
4. Selling rates must not be lower than the contracted rates specified herein and minimum mark up of 20% is required. The hotel does not permit distribution of the contracted rates via the Internet and prior consent in writing from the hotel is required.
5. This contract rate is strictly for your company's use and is not available to any corporate accounts, or commercial firms. Subcontracting to other agencies or tour operators, and display of rates on the Internet are also prohibited.
6. Maximum occupancy in each guest room is three registered guests per room.
7. The official check-in time at the hotel is 3:00pm. The hotel will make every reasonable effort to accommodate early arrivals depending on occupancy. If you prefer to guarantee that all guestrooms are ready prior to the guests' early arrival, we suggest that the rooms are reserved one night prior to the arrival date at the rate quoted. All early check-in requirements are requested with advanced notice and confirmed subject to hotel availabilities.
8. The official check-out time is 12:00 noon. Late check-out can be arranged until 6:00 pm at 50% of the rate quoted. Check-out after 6:00 pm is subject to a one-night charge. All late check-out and extension are requested with advanced notice and confirmed subject to hotel availabilities.
9. Early departure: Unused room nights are not refundable for early departure unless notice is given to the Hotel at least 3-day prior to arrival.
10. All reservation must be guaranteed in writing or prepayment. 
