GROUP BOOKINGS: Rates do not apply to groups (10 Villas or more). Group rates are available on request.

COMPULSORY MINIMUM LENGTH OF STAY AND RESTRICTIONS

TRANSFER OPTIONS:

MAAFARU INTERNATIONAL AIRPORT:

With direct access for private jets to Maafaru International Airport, the journey to Velaa Private Island has become even easier. Our luxury yacht transfer pick up guests from Maafaru for a quick 35 minute direct journey to our island paradise. International flight operations began on 1 December 2019. Maafaru International Airport operates 24 hours a day and features a 2,200 meter runway that can handle private jets as well as commercial aircrafts the size of Airbus A 320's and the Boeing 737's.

TRAVELLING FROM MAAFARU INTERNATIONAL AIRPORT TO VELAA PRIVATE ISLAND

SEAPLANE TRANSFER:

Transfers from the seaplane terminal at Velana International Airport (Malé) and Velaa Private Island:

- We encourage to book charter seaplane for guests travelling by private jets to avoid waiting hours and to have direct flight to resort. Charter aircraft has to be booked 72 hours in advance.
- Velaa branded seaplane is available on request, only for private charter flights.
- Velaa branded seaplane is subject to availability - 9 seats only. One way trip from/to Velana International Airport and Velaa Private Island.
- Velaa branded seaplane will be scheduled based on international flight arrival or departure timings. Should the guests be delayed Velaa reserves the right to make alternate arrangements with TMA Standard aircraft at the contracted rate, flight timing is subject to availability.
- Due to any technical related non-availability of the Velaa branded Seaplane an alternative seaplane by TMA VIP or standard charter aircraft will be arranged by Velaa Private Island, based upon availability.

- Rates are non-commissionable.
- Pricing is subject to change by the carrier without prior notice. Should there be a change during the term of this agreement, the revised pricing will be applied to all imminent and future reservations.
- Seaplane transfers to and from the Velaa Private Island are operated by independent airline Trans Maldivian Airways (TMA). All guests' arrival and departure seaplane transfer must be booked by Velaa Private Island.
- International flight details must be provided at least 14 days prior to the arrival date in order to ensure best seaplane transfer connection.
- If the flight details are not provided until 5 days prior to the travel date, we will not be able to guarantee the best connection.
- In case of a last minute transfer request, you might have to arrive or depart from another Island nearby. Additional charges may apply if we are to arrange transfer between Velaa and another Island.
- Due to restrictions on seaplane operations in the Maldives, seaplane aircrafts are operated only during day light between 6am to 5pm. If international flight is arriving after 3.30 PM or is departing before 9 AM guest are to arrange overnight accommodation in Malé before or after their flight.
- Baggage allowance is 20kg for checked luggage and 5kg for hand luggage per person. For regular TMA charter seaplane, baggage allowance is 300Kg total, Velaa branded VIP charter flight baggage allowance is 230 kg total. Any excess of luggage is chargeable at USD 5 per kg subject to 10% service charge and 17% TGST, which can be paid directly to TMA upon check-in at the seaplane terminal. Excess baggage might be transferred on the next available flight, on the same day or on the following day.

- The journey will take approximately 50 minutes. There might be up to 2 stops at other resorts only for shared seaplane. TMA will make their best efforts to ensure no more than one stop is encountered during the transfer to and from Velaa Private Island. TMA will use its best endeavours to ensure that arriving passengers are departing from the seaplane airport within 2 hours from the time they check in at TMA terminal, subject to the international connection landing on the time published (STA), and to the passengers clearing arrival procedures and reporting to the TMA check in desk within 1 hour from the landing of the international flight.
- Seaplane cancellation, amendment made within 72 hours prior to arrival date and no show will incur a cancellation fee of 100% of the total charge.
- Please note that transfers price might change without prior notice as this service is provided by a 3rd party company.

PASSPORT VALIDITY:

Your passport must be valid for at least 6 months from date of travel. It is the sole responsibility of the Guest to obtain the necessary visa required for the stay at the Resort for the entire duration of the stay. Velaa Island Maldives Pvt. Ltd. will not be responsible for and will not be liable for any losses faced by the Guest due to the Guest's inability to obtain or extend the visa.

GUESTS' ARRIVAL AND VELAA LOUNGE

Upon arrival to Velana International Airport, guests will be greeted by our airport representative, who will assist them with the check-in for the seaplane and escort them to our airport lounge at the Seaplane Terminal where they can choose to freshen up with our shower facilities or relax in comfort until departure.

Upon arrival to Velaa Private Island, guests will be met by the resort management and their butler, who will be assigned to them throughout their stay and ready to assist at any time. Our butler will be delighted to arrange an Island Tour, either as soon as guests arrive or at any preferred time during their stay.

CIP SERVICES

The resort may arrange CIP services upon request offered by Velana International Airport on arrival and departure which minimizes waiting time for formalities and ensures a smooth transfer. A charge of USD 290 net will be applied per person per way.

CANCELLATION POLICY

In case of a cancelled or shortened reservation, Company must inform the Resort in writing as soon as possible. The Resort shall be entitled to apply the following cancellation charges:

- Celebration
 - The first 50% payment is Non Refundable in an event of a cancellation after reservation is confirmed.
 - The other 50% payment will be refunded, if cancelled or modified up to 90 days before date of arrival. If cancelled or modified less than 90 days prior to arrival or in case of no-show, the total price of the reservation will be charged as cancellation.
- Stimulation
 - Easter period (1-16 April 2026): Cancellations or amendments made within 60 days prior to arrival date, will incur a cancellation fee of 100% of the total room charge.
 - Other periods: Cancellations or amendments made within 45 days prior to arrival date, will incur a cancellation fee of 100% of the total room charge.
- Relax & Escape and Turtle
 - Cancellations or amendments made within 30 days prior to arrival date, will incur a cancellation fee of 100% total room charge.

AMENDMENT

Any changes to the stay dates, length of stay or change in name, will incur a cancellation charge as per Resort's cancellation policy.

NO-SHOW POLICY

A reservation is considered a no show if arrival does not occur on the date reserved. No-shows will be subject to 100% of the accommodation rate for the entire period of the reservation.

EARLY DEPARTURE

In the event of guest check out earlier than reserved date, full room charge will apply on the remaining reserved nights.

PAYMENT POLICY

- Celebration
 - 50% of total room charge is due at time of booking (this payment is Non Refundable).
 - Remaining 50% must be received 90 days prior to arrival.
- Stimulation
 - Stays over Easter period (1-16 April 2026). Full prepayment must be received before 25 Jan 2026.
 - Bookings after 25 Jan 2026 for Easter period stay will require 100% of total room charge due at time of booking.
 - Other periods: Full prepayment must be received 60 days prior to arrival.
- Relax & Escape and Turtle
 - Full prepayment must be received 45 days prior to arrival.

Important Notes:

- To ensure that payments are received prior to the guests' check-in to the resort, all bookings confirmed less than 07 days prior to the arrival date (excluding weekends) shall be paid using credit/debit card and bank transfers may not be accepted. Once reservation is confirmed, we will be sending an online credit/debit card link to make the payment. For these last-minute bookings, credit/debit card commission will not apply.
- For all other credit/debit card payments, the following credit/debit card commission will apply:
 - Visa/MasterCard – 2.85%
 - American Express – 3.5%
 - Union Pay – 2.75%
- In the case of direct payments made by guests or bookings made through travel agents including your markup, we will only issue net invoices up to our published rates.
- If full payments, including the transfers, are not made on time, the Resort reserves the right to release the reservation. Payment preferable by bank transfer.

Our team will send a tentative confirmation and Advance Payment Statement within 24 hours of receipt of the E-mail. Please note that Reservation will be considered as a firm confirmation after the Resort receives payment from the Company as per the payment terms in this agreement.

ROOM ALLOCATION

Please note that requests for specific villa numbers, villa locations or villas close to or next to each other may not be guaranteed in advance. If there is any such request, the Resort will take note of the same and will try their best to allocate villas accordingly, subject to availability at the time of arrival.

OVER WATER UNITS CHILD POLICY

Due to open design and proximity to the water of the water units, the Resort strongly encourage guests with children below the age of 12 years to consider booking beach units. If the Company's guests who travel with children below 12 years would like to book the water units, the Resort requires the signing of a liability agreement.

NO DRONE POLICY

While we recognise that we have guests who are drone enthusiasts, we must maintain an environment that respects our guests' right to comfort and privacy. As such, we cannot allow guests to fly Drones during their stay in our resort.

Velaa Spa and Wellbeing has been created as an adult sanctuary, therefore children under the age of 12 years are permitted for specially designed treatments when accompanied by a guardian at all times, however they are restricted to access the complimentary recreational Spa and Wellbeing facilities. Children from age 12 to 16 years are welcome to use complimentary recreational Spa and Wellbeing facilities, but must be accompanied by a guardian at all times.

CLOSURE OF TENNIS COURT – FESTIVE SEASON

To be able to offer our guest the most extraordinary festive events, please note that the covered tennis court will be closed from 18 Dec – 21 Dec 2025 and from 28 Dec 2025 – 1 Jan 2026 unless otherwise informed by the management. Rest assured our football pitch will be available for sports usage including tennis.

TERMINATION

The agreement can be terminated by either party with a 30 day written notice.

ASSURANCES

Upon written notice, a party may terminate this Agreement immediately if any other party ceases to do business, becomes insolvent, or is subject to bankruptcy or insolvency proceedings. If the Agreement is terminated, all future arrivals will convert to 100% prepayment. All outstanding balances must be paid by Company prior to Resort accepting future arrivals. If reasonable grounds for insecurity arise about a party's performance of this Agreement, then any other party may demand written adequate assurance of due performance. Until the requesting party receives such assurance in writing, it may suspend its performance of this Agreement. If the written assurance is not received within 5 days after its request, or within such other reasonable period of time as a requesting party may designate, then the failure to furnish such assurance constitutes a material breach of this Agreement, and the requesting party may immediately terminate this Agreement.

BREACH OF CONTRACT

If the Company breaches any of the provisions of this Agreement, and fails to promptly attend to such breach, the Resort may refuse to confirm any reservations from the Company and terminate this Agreement immediately without any written notice.

RELOCATION POLICY

The Resort shall treat any Company guest at least equally as the Resort treats any other Resort guest, including, without limitation, how the Resort handles overbooking (i.e. "walk out") situations. If Resort is unable to honour a guest reservation after all other efforts to relocate direct bookings and other guests have been made by Resort, then Resort shall immediately (a) notify Company of such inability, (b) relocate the guest to a property that is of an equal star quality rating than Resort, (c) prepay or make other arrangements to cover the room charges at such property for first night room and tax and all transportation costs to such property, and (d) deliver a written explanation absolving Company of responsibility for Resort's failure to honour the reservation. Company shall not be responsible for any amounts owing to Resort related to such guest reservation in the event the guest remains dissatisfied (as agreed upon by Company and Resort).

INDEMNIFICATION

Resort shall, at its expense and at Company's request, hold harmless, indemnify and defend such Company, any affiliate, or any of their directors, employees, or agents, against any third-party claims or actions brought against any of them, arising from or relating to Hotel/Resort's accommodations or services or Resort's breach of this Agreement. The Company shall, at its expense and at Resort's request, indemnify, defend and hold harmless the Resort against any third-party claims or actions brought against the Resort, any of its affiliates, or any of their directors, employees or agents relating to Company's breach of this Agreement or incorrect booking of reservations through the Company's System. The booking of reservations through the Company's system shall be deemed to be incorrect in case that a reservation is not made in accordance with this Agreement (has not been acknowledged by the Resort's reservation department) – in such a case, the Resort shall not be bound by the incorrect reservation and the Company shall indemnify the Resort for any third party claim made in connection with the incorrect reservation.

CONFIDENTIALITY

Without the express written and signed consent of the disclosing party, no party shall disclose or allow the disclosure to any third party, or use other than as specifically permitted in this Agreement, any confidential, proprietary or trade secret information of such disclosing party. Terms and conditions of this Agreement and especially the Contract Rates are always deemed to be confidential. A party shall not be liable for the disclosure of any confidential, proprietary or trade secret information if such information (a) becomes publicly available without the receiving party's breach of any obligation owed to the disclosing party, (b) become known to receiving party prior to disclosing party's disclosure of such information, (c) become known to receiving party from a source other than disclosing party where such source did not breach an obligation of confidentiality owed to disclosing party, or (d) is independently developed by the receiving party. If Company provides Resort access to an extranet, Resort shall keep confidential, and require Resort's employees and agents to keep confidential, all passwords and other security measures necessary to access such extranet.

AGREEMENT CONFIRMATION

This Agreement is deemed valid once the signature page of this Agreement has been duly signed by both parties and returned to Resort’s sales department. Unless and until the Resort receives from the Company a counter-signed contract, there shall be no agreement of the parties and the terms hereof shall be of no force.

MISCELLANEOUS

The Company may not assign any of its rights or obligations under this Agreement without the Resort’s prior written consent; provided, however, nothing herein shall prohibit Company from assigning any of its rights or obligations to an affiliate.

GOVERNING LAW

This Agreement is governed by, and shall be construed in accordance with the laws of the Republic of Maldives and the parties to this Agreement hereby agree to submit to the jurisdiction of such courts of the Republic of Maldives. Each of the undersigned has carefully read and understands the contents of this Agreement.

FORCE MAJEURE

During the term of this Agreement, neither party shall be in default of its obligations to the extent that its performance is delayed or prevented by causes beyond its reasonable control, including but not limited to natural disasters, bankruptcy of a vendor, strikes and other labour disturbances, acts of war or civil disturbance, or other equivalent or comparable events.
