- For Direct Guest booking or Travel Advisor booking, without having advised that it would be taken over by a Travel Advisor/ wholesaler/ Tour Operator, the hotel might reserve the right not to apply the Travel Advisor/ Tour Operator terms and conditions.

RATES

- **Rates are dynamic and therefore may change depending on demand without prior notice. For you to know which rate to apply please contact our Reservations team.**
- **Best available rates, cancellation and payment policies will be confirmed at the time of request with an email for reference.**
- Tour operator rates may be under availability restrictions during high occupancy periods and festivities.
- Rates and below conditions are valid for a maximum of 5 villas. Please contact us for rates & conditions for bookings of 6 villas or more.
- Rates are per villa per night, quoted in US dollars subject to 10% service charge and 17% Goods & Service Tax.
- Rates are based on single or double occupancy in one-bedroom villas and on single to quadruple occupancy in two-bedroom villas and include daily international breakfast (for up to 2 guests in all one-bedroom villas and for up to 4 guests in all two-bedroom villas).
- A Green Tax of USD 12 per guest, per night will apply for all bookings for all guests, except for children under 2 years old.

- As per Cheval Blanc Randheli's sales policy, **you must fully respect rate transparency and full parity with final guests.**

RESERVATIONS

- Reservation requests or amendments must be made in writing directly to Cheval Blanc Randheli at res.randheli@chevalblanc.com. A booking confirmation will be sent upon receipt of the required deposit as per the seasonal payment policy detailed below.
- When processing a reservation, kindly provide complete guest's contact details including names as per passport, international flight details and accommodation type.
- To ensure a smooth airport arrival process, we also require a photocopy of guests' passports prior to arrival. We kindly ask you to send these scanned documents at least 24 hours prior to arrival.
- The Maison's Alchemists will contact you prior to arrival to obtain the guest's preferences and propose tailor-made activities and experiences. Please send back to us the Guest Preferences Questionnaire, sent upon reservation confirmation.
- In case the Guest Preferences Questionnaire is not received in a timely manner, our Maison reserves the right to contact the involved travel agent (if any) directly, copying you.

MAISON POLICIES

- Check-in time is at 14:00 and check-out time is at noon.
- Cheval Blanc Randheli is on GMT+6, 1 hour ahead of Male' time.
- The Maison strongly recommends booking the night before in case of an early arrival and the night after in case of a late departure (please note the seaplane operates only during daylight hours).
- Additional beds: Possibility of rollaway beds, day beds or baby cots.
- Children less than 4 years old stay on a complimentary bed and breakfast basis.
- A Green Tax of USD 12 per child per night is chargeable for all guests, except for children under 2 years old.

- For children from 4 up to 12 years old, the extra person rate is USD 220 per day including daily international breakfast, subject to a 10% service charge and the 17% Goods & Service Tax.
- For guests 13 years old and above, the extra person rate is USD 400 per day including daily international breakfast, and subject to a 10% service charge and the 17% Goods & Service Tax.
- The Maison will not accept reservations for children under the age of 11 years old occupying a villa alone. Guests with children under 10 years old are encouraged to book Island Villas. In case of booking in a different villa category, a mandatory signed waiver form will be required.

If the partner breaches any of the provisions of this agreement and fails to promptly cure such breach, then Cheval Blanc Randheli may refuse to confirm any reservations from the partner and terminate this agreement immediately without any written notice.

ASSIGNMENT

The partner may not assign or sub-contract this agreement to any other person or entity. This agreement does not create a partnership or agency relationship between or among the parties.

ACCEPTANCE

Please sign and return the enclosed copy of this agreement and initial each page. Once the signed agreement is received, it will constitute a binding agreement between both parties. Please keep a copy of this agreement for your records.

GOVERNING LAW AND DISPUTES

This agreement is governed by and construed in accordance with the laws of the Republic of Maldives for the time being in force and the parties agree to submit any dispute arising between the parties under this Agreement.

FORCE MAJEURE

During the term of this agreement, neither party shall be in default of its obligations including but not limited to force majeure situations such as natural or health disasters, bankruptcy of a vendor, labour disturbances, acts of war or civil disturbances, or other equivalent or comparable events.
