## • PAYMENT POLICIES :

- Pre-payment upon confirmation of 50% of the stay
- Final balance, 30 days prior guest's arrival
- In case of balance, the payment must be settled upon receipt of invoice

## • CANCELLATION & MODIFICATION POLICIES :

Any total or partial cancellation must be sent to the hotel in writing and dated.

In case of cancellation, the hotel reserves the right to demand:

- More than 15 days prior to guest's arrival : free cancellation
- Less than 15 days prior to arrival : 50% of the total amount of the stay
- Modification less 15 days prior arrival or during the stay : 100% of the total amount of the stay

Please note that in case of no-show or/and early departure, the total number of nights originally booked will be totally charged as a cancellation fee.

• **MISCELLANEOUS :**

Both parties acknowledge the strictly confidential nature of the contract they have signed, in particular the pricing details contained therein.

• **DISPUTE SETTLEMENT :**

We would remind you that our agreement is legitimate and binding (even in the case of an agreement replicated by you). All disputes or disagreements regarding the contract's interpretation or performance shall come under the exclusive jurisdiction of the Commercial Court of Fréjus, which will apply the law.
