The confidential net rates provided are valid for the period indicated in this agreement and would be subject to change only if a change with the Mexican Taxes occurred. This agreement must be duly signed and returned to the Hotel to be effective.

**NET RATES**

Under the terms of this agreement, the Hotel assigns to the Agency an exclusive reservation code, identified as **NUBA**. Agency can quote using its code on **Nômade Temple** website, with discounted rates plans 20% before taxes.

The Hotel agrees to apply a price match policy, honor the lower rate in the event of any discrepancy between the rate accessed via the **NUBA** code and the rate published on the Hotel's official website for identical booking conditions (including dates, room type, and cancellation policies).

Rates are:

- Per room, per night, subject to 21% Taxes and 10% of Service Charge
- Based in single or double occupancy.
- Extra person charge applies at \$125 USD per night plus 21% taxes and 10% of Service Charge

#### VII.- GENERAL:

Such causes include but are not limited to acts, regulations, or orders of governmental authorities, fire, flood or explosion, war, disaster, civil disorder, curtailment of transportation facilities or other emergency making it illegal or otherwise impossible to provide the facilities or their service hold the meeting, any delay in necessary and essential construction or renovation of the Hotel, strike, lockout or work stoppage or the restraint of labor, either partial or general form ti whatever cause.

#### IX.- MISCELLANEOUS:

The Hotel's failure to promptly enforce any provision of this contract shall not be deemed a waiver of such provisions. This contract shall be governed by the laws of the State of Quintana Roo, Mexico and may not be modified except pursuant to a written instrument signed by the hotel.


