Warm greetings from Velaa Private Island.

We are pleased to share the addendum to the 2026 Velaa Private Island preferred partner agreement. Kindly find below a summary of the key updates:

- Extension of the contract period until 12 January 2027.
- Addition of 2026/2027 Celebration Season rates, including festive supplements and applicable charges.
- Decrease in Ocean Pool House rates (other rates remains the same).
- Update to maximum occupancy for Beach Pool Villas.
- Introducing One-Way TMA shared seaplane transfer rates valid until 19 December 2026, instead of the round-trip rates stated in the original contract.
- Adjustment to TMA shared seaplane transfer rates for the 2026/2027 Celebration Season (all other transfer rates remain unchanged).
- Revision of CIP service charges.
- Updates to all dates related to the 2026/2027 Celebration Season, including compulsory minimum length of stay and tennis court closure dates.

In addition, we would like to inform you that Velaa Private Island will be closed for business from 1 September to 30 September 2026.

PAYMENT & CANCELLATION POLICY

Celebration

- 50% of total room charge is due at time of booking (this payment is non refundable).
- Remaining 50% must be received 90 days prior to arrival.
- Any cancellations or amendments within 90 days of arrival date are subject to 100% cancellation charge.

All other terms and conditions relating to the other seasons remain unchanged and shall apply as per the original contract.

CIP SERVICES

The resort may arrange CIP services upon request offered by Velana International Airport on arrival and departure.

Below net charges will be applied per person per way:

- **1 January – 31 August 2026:** USD 354 per adult, USD 257 per child (2 – 11 years) and USD 97 for accompanying non-travelling person.
- **1 October 2026 – 12 January 2027:** USD 515 per adult, USD 386 per child (2 – 11 years) and USD 97 for accompanying non-travelling person.

Rates are inclusive of 10% Service Charge & 17% TGST (Tourism goods and service tax) and are non-commissionable.

CLOSURE OF TENNIS COURT – FESTIVE SEASON
