Dar es Salaam - Songo Songo / Songo Songo - Dar es Salaam routes require a minimum of 4 passengers per booking to induce Coastal Air to operate the flight. In order not to charge the guests for the extra seats, Laba Laba will pay for 2 seats. In this way, a couple of passengers will only have to pay for their two seats. Each flight is checked 48 hours before departure, should the minimum inducement be met, a refund will be allowed.

CHILD POLICY

No children under 12 are allowed at the Light House Restaurant. Families traveling with children under 12, can have all their meals (including breakfast) at the main area/lounge. TERMS AND CONDITIONS OF TRADING

For Laba Laba Limited, operating the camps known as Laba Siwandu, Laba Jongomero, Laba Migration Camp, Laba Grumeti Art Lodge, Out of Africa Legend by Laba Explorer, Laba Mama Symba, LABA Ngorongoro Lodge and Laba Fanjove, all of P.O. Box 1192, Dar es Salaam, Tanzania, East Africa.

BOOKINGS

- a) Reservations shall be confirmed in writing (letter or email, not by phone)
- b) Bookings shall be considered confirmed only when accompanied by a NON-REFUNDABLE 20% deposit.
- c) The balance (80%) must be paid 30 days prior to arrival. If a reservation is made within 45 days prior to arrival, full payment is due. For a group booking (3 tents or more), the balance needs to be paid 60 days prior to arrival.
- d) All contract rates must be respected by agents in order to maintain the integrity of the LABA LABA brand. Failure to sell at full rate to end user may result in revoking of any rate and this agreement will be null and void.

CANCELLATIONS AND REFUNDS

Any cancellations of a reservation must be in writing and shall only be effective upon its acknowledged receipt by the Company. Cancellation charges shall be as follows:

a) Charged on invoiced rate for cancellations:	over 60 days	20%

Cancellations for group bookings (3 tents or more)	over 120 days	20%

b) No refunds are given:

- (1) for lost travel time or substitution of facilities,

- (3) for circumstances arising beyond the Company's control necessitating alternative arrangements to be made to ensure the safety and/or further participation and enjoyment of your program,
- (4) if you do not appear for any accommodation, service, sightseeing or trip segment without notifying the Company well in advance, or
- (5) if you leave the properties prematurely or miss any scheduled activities or accommodations.

ACCESS

We cannot be held responsible for road and airstrip conditions, which may at times render access to and from the resort impossible. Any changes made to the initial booking are subject to the conditions and rates, even if caused by weather conditions.

RISKS

a) All international guests will be automatically issued with a Flying Doctors www.flyingdoctorsafrica.org medical insurance policy. This policy costs US\$15 for your stay with LABA LABA properties. a 14 day stay in East Africa, if your guests are staying longer we can offer a longer policy of 2 month for US\$50 and can be used at both LABA LABA properties and other East African properties. On confirmation, the policy documents will be emailed to you with all the 24hour emergency service details; please give ALL this information to the guest and in case of emergency the camp will facilitate any designated evacuation and provide communication facilities for the guests to converse with Flying Doctors but will take no responsibility to evacuate guests. If you have any questions or already provide this cover for your guests please let your reservations consultant know.

b) The Company and its owners, directors, management and employees shall not be held responsible for any illness, injury or death to persons visiting the resort nor for loss or damage to personal property, however they may be caused.

c) The Company draws your attention to the fact that there are certain inherent risks involved in visiting the properties owned and managed by the Company and that you accept them at your own risk.

d) It is your sole responsibility to take all appropriate medical advice prior to departure as to whether or not you are fit enough to undertake the trip booked.

e) The Company shall not be responsible for risks arising from circumstances which are out of the control of the Company such as environmental pollutants, radioactive contamination, nuclear waste, the combustion of nuclear fuel, or toxic, explosive or other hazardous properties of any nuclear component of the same or war, invasion, act of foreign enemy, hostilities, civil war, rebellion, government intervention, quarantine, fire, floods.”

f) The Company will not assume any liability whatsoever to persons visiting its facilities for any act or omission of the Company done in good faith or arising from circumstances beyond the reasonable control of the Company

FORCE MAJEURE

a) “Force Majeure” means, in relation to the Company, any circumstances beyond the reasonable control of the Company (including without limitation, acts of God, explosion, flood, tempest, fire or accident, war or threat of war, sabotage, insurrection, civil disturbance or requisition, sickness, quarantine, government intervention, weather conditions or other untoward occurrences).

b) If the Company is affected by Force Majeure it shall forthwith notify you of the nature and extent thereof.

c) The Company shall not be deemed to be in breach of these terms and conditions or otherwise be liable to you, by reason of delay in performance, or by non-performance, of any of its obligations hereunder to the extent that any such delay or non-performance is due to any Force Majeure.

d) If the Company is affected by Force Majeure it shall be entitled to, and may at its sole and absolute discretion, vary or cancel any reservations or arrangement in relation to the visit. Payment of any refund by the Company to you as a result of the nonperformance of any of the Company’s obligations hereunder shall remain in its sole and
