### **A. Rates**

Daily Public Best Available Rates inclusive of tax & service (excluding City Tax).

This agreement will apply to your individual bookings only, up to 10 rooms

### **B. Resale**

### **C. Intuitu personae / Non-transferability**

Monte-Carlo Best Partner shall not transfer, directly or indirectly, by any way (including by operation of law or otherwise including without limitation any merger and acquisition) the benefit of the special conditions to any third party.
